

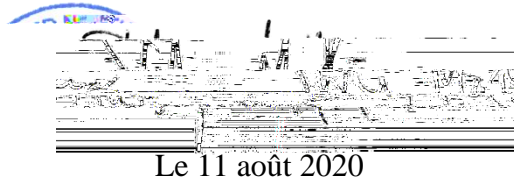

la Commission de vérification des pouvoirs* ».

Le Bureau des affaires juridiques saisit cette occasion pour renouveler aux  
missions permanentes des États parties à la Convention des Nations Unies sur le droit de  
la mer les assurances de sa très haute considération.

Excellencies,

I refer to my letters dated 30 July and 5 August 2020, and decision 30/1 of 24 July 2020. I refer also to agenda items 4 (Adoption of the agenda), 5 (Election of Vice-Presidents) and 6 (Appointment of the Credentials Committee) on the provisional agenda of the thirtieth Meeting of States Parties ([SPLOS/30/L.1/Rev.1](#)).

Having consulted with States Parties, and having also received an additional nomination for the position of Vice-President of the thirtieth Meeting of States Parties and nominations for membership of the Credentials Committee, I hereby propose for adoption three decisions entitled respectively as follows: “*Adoption of the agenda*”, “*Election of Vice-Presidents*” and “*Appointment of the Credentials Committee*”.

(a) “*Adoption of the agenda*”

I propose, again, the adoption of the provisional agenda as contained in document ([SPLOS/30/L.1/Rev.1](#)). The provisional agenda is annexed for ease of reference. Editorial adjustments by the Secretariat to reflect documents issued after the provisional agenda had been issued, which were tracked in the version annexed to my letter of 30 July 2020, have been incorporated.

**The proposal to adopt the provision**

*(b) "Election of Vice-Presidents"*

I have the privilege of informing you that I have received, through the Secretariat, the following nominations:

- For the seat allocated to the Group of African States: H.E. Mr. Ibrahima Toure (Côte d'Ivoire);
- For the seat allocated to the Group of Eastern European States: Mr. Oleksiy Ilnytskyi (Ukraine);
- For the seat allocated to Group of Latin American and Caribbean States: Mr. Edgar Daniel Leal Matta (Guatemala); and
- For the seat allocated to the Group of Western European and Other States: Mr. Cary Scott-Kemmis (Australia).

I propose that each of the above-mentioned candidates be elected as Vice-President of the thirtieth Meeting of States Parties.

Accordingly, **the proposal to elect H.E.**

I propose that each of the above-mentioned States Parties be appointed as a member of the Credentials Committee of the thirtieth Meeting of States Parties.

Accordingly, **the proposal to appoint Chile, the proposal to appoint China, the proposal to appoint Finland, the proposal to appoint Honduras, the proposal to appoint Monaco, the proposal to appoint Myanmar, the proposal to appoint Namibia, the proposal to appoint the Russian Federation, and the proposal to appoint Sierra Leone as members of the Credentials Committee of the thirtieth Meeting of States Parties are placed under a silence procedure until 5 p.m. on Friday, 14 August 2020.**

Any objection to any of the above-mentioned nine proposals should be transmitted in a letter or a note verbale addressed to me, with a clear indication of the proposal(s) which the objection(s) refer(s) to. I take this opportunity to highlight to States Parties that the election of seven members of the International Tribunal for the Law of the Sea is a matter that must be dealt with urgently. The establishment of both the Bureau and the Credentials Committee as soon as possible is therefore of critical importance.
