I Introduction

Delegations that have nominated candidates for the elections and who wish to distribute hard copy campaign material in support of their candidates, can do so by delivering physical copies of such material to the Permanent Mission of Singapore to the United Nations no later than 5:00 pm on 21 August 2020. Given the need to mitigate risks,

“Floating seat”

On the basis of the “Arrangement for the allocation of seats on the International Tribunal for the Law of the Sea and the Commission on the Limits of the Continental Shelf” approved by the nineteenth Meeting of States Parties on 26 June 2009 as contained in document SPLOS/201, one member is to be elected from among the Group of African States, the Group of Asia Pacific States and the Group of Western European and Other States (“the floating seat”). Following the withdrawal of the candidature of Mr. Haplias Zhorby by the Government of Zimbabwe, only those candidates from the Group of Western European and Other States can be considered for the floating seat.

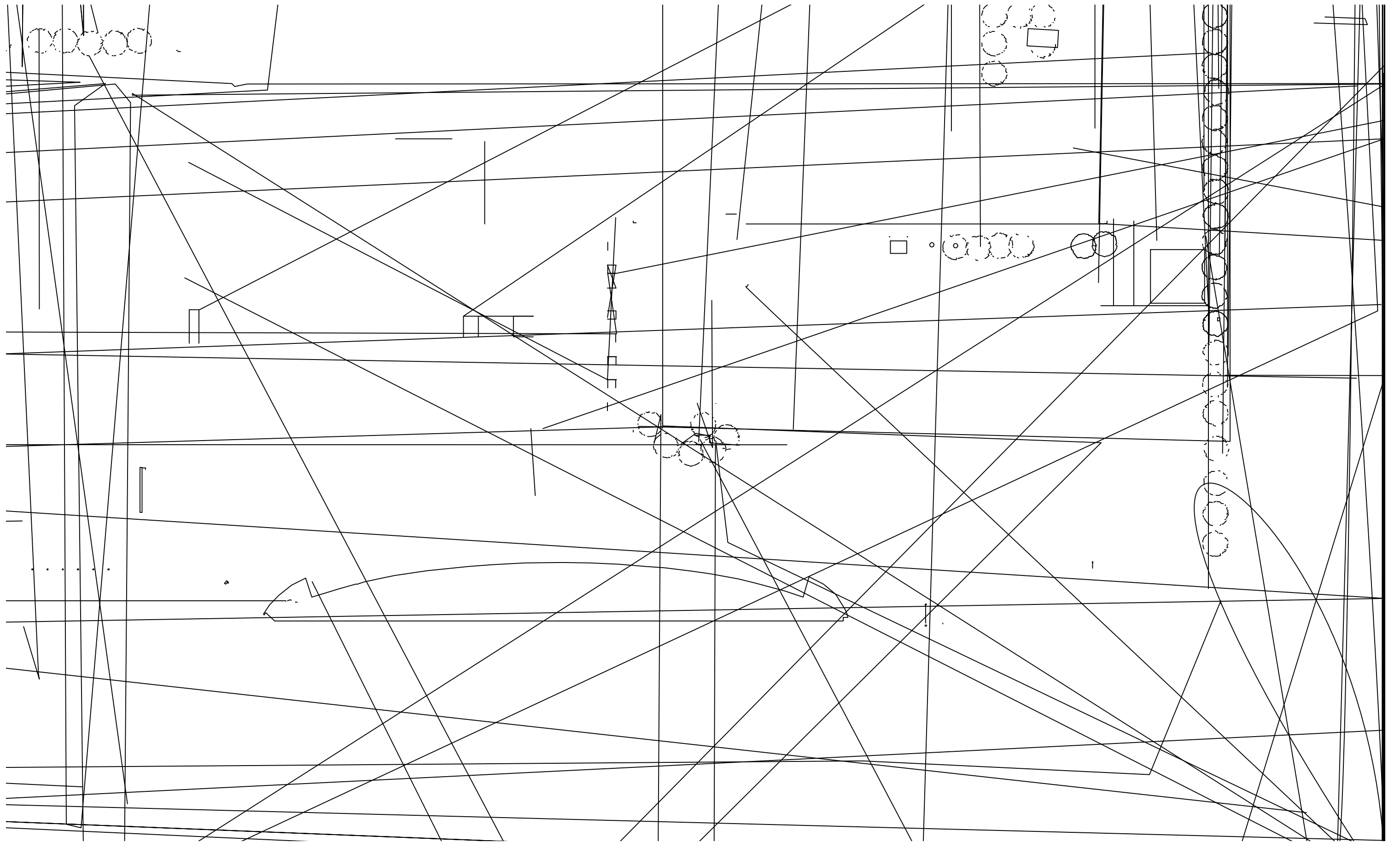

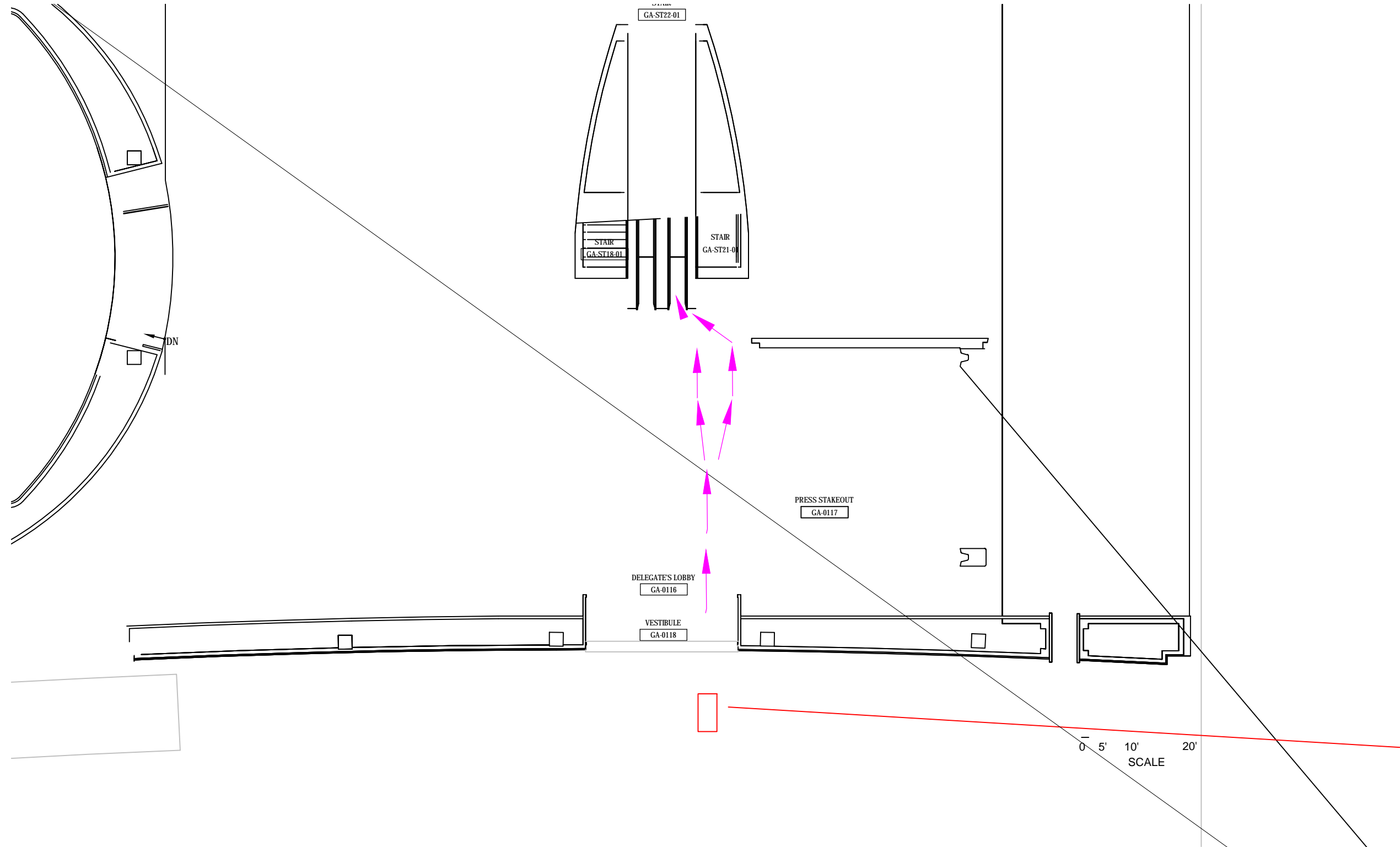

Use of restrooms

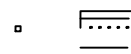
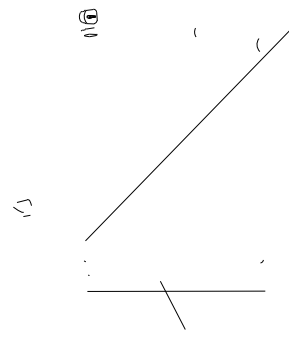
