DESCRIPTION OF REQUIREMENTS

The United Nations Global Service Centre (UNGSC) seeks a qualified contractor to establish a long-term contract for an initial period of three (3) years with the option to extend for 2 additional one-year periods, for the Provision and Maintenance of Water Dispensers, including the Provision of Mineral Water and Disposable Cups, in its premises located in Brindisi, Italy.

The service to be provided under this requirement is divided into two distinct components as follows:

Part 1: Supply and Distribution of Mineral Water Bottles and Disposable Paper Cups

- Water Bottles: Supply 18-liter PET bottles with natural mineral water compliant with Italian D.Lgs. 31/2001 (approximately 5000 units per year). Bottles must be palletized, labeled with a minimum 1-year shelf life.
- Paper Cups: Provide recyclable 240cc paper cups (approximately 3600 units per year), capable of handling temperatures from -20°C to +90°C, packaged in secure packs of 50.
- Distribution and Collection Services: Weekly delivery and collection service for water bottles across 52 distribution points within the UNGSC compound. Includes cleaning and disinfection of dispenser drip trays.

Part 2: Water Dispenser Supply, Installation, and Maintenance

- New Dispensers: Supply and install dispensers (approximately 10 units per year) for 18-liter bottles with sanitizable circuits, stainless steel hot water tanks, and push-type faucets with hot water safety features.
- Maintenance Services: Biannual routine and repair maintenance on approximately 52 dispensers and any additional units that may be purchased through the new contract, covering external/internal cleaning, descaling, filter replacement, and functional testing as per Italian standards.

The regular maintenance service includes, but is not limited to, cleaning, sanitization, sanitation, periodical maintenance, and testing of electrical and mechanical parts, including the replacement of all necessary parts for the new and the existing water dispenser at UNGSC.

The maintenance services shall include all materials, equipment, and labor required to complete the works as per the best practices applied in the market.

The complete technical requirements and administrative instructions will be provided with a solicitation document to be issued at a later stage following the closing date for this EOI.

Please note split awards will be allowed, so bidders can express their interest in Part 1, Part 2 or both.

The UNGSC will provide the complete technical requirements and administrative instructions with a solicitation document to be issued later after the closing date for this EOI.

This REOI does not constitute a solicitation. The UNGSC reserves the right to change or cancel the requirements during the REOI and solicitation process.
