


Preliminary Information regarding the Outer Limits of the Continental Shelf

Pursuant to paragraph 8 of Article 76 of the United Nations Convention on the Law of the Sea 1982 and the decision of the Eighteenth Meeting of States Parties to the UNCLOS(SPLOS/192),



Introduction

The Republic of Korea (hereafter referred to as "Korea") signed the United Nations Convention on the Law of the Sea 1982 (hereafter referred to as "the Convention") on 14 March 1983, and ratified the Convention on 29 January 1996. The Convention entered into force for Korea on 28 February 1996.

Korea extended its territorial sea to 12 M with effect from 30 April 1978 (Territorial Sea Act, No. 3037) and its contiguous zone to 24 M with effect from 1 August 1996 (Territorial Sea and Contiguous Zone Act, No. 4986), and proclaimed a 200 M exclusive economic zone with effect from 10 September 1996 (Exclusive Economic Zone Act, No. 5151).

Through the Submarine Mineral Resources Development Act (No. 2184) of 1 January 1970 and the subsequent Presidential Decree (No. 3020) of 30 May 1970, Korea proclaimed sovereign rights over the seabed and subsoil outside the coast of Korea as regards the exploration and exploitation of natural deposits, taking into account that the rights of the coastal State over the continental shelf exist *ipso facto* and *ad initio*.

On 30 January 1974, Korea and Japan signed the Agreement between the Republic of Korea and Japan Concerning the Development of the Southern Part of the Continental Shelf Adjacent to the Two Countries (hereafter referred to as "the 1974 Agreement"), which created a mechanism to carry out jointly

exploration and exploitation of natural resources over the continental shelf in the
East China Sea.

In accordance with Article 76 of the Convention and the decision of the
Eighteenth Meeting of States Parties to the Convention (SPLOS/183), Korea has
decided to submit to the Secretary-General of the United Nations (hereafter
referred to as "the Secretary-General") preliminary information indicating the
outer limits of the continental shelf beyond 200 M, a description of the status of
preparation and the intended date of making a submission in accordance with the
time period referred to in Article 4 of Annex II to the Convention and the
decision of the Eleventh Meeting of States Parties to the Convention (SPLOS/72).

Korea takes note of paragraph 1(b) of SPLOS/183 which states that, pending the
receipt of the submission in accordance with the requirements of Article 76 of the
Convention and with the Rules of Procedure and the Scientific and Technical
Guidelines of the Commission on the Limits of the Continental Shelf (hereafter
referred to as "the Commission"), preliminary information submitted in
accordance with SPLOS/183 shall not be considered by the Commission.

Korea also notes that, in accordance with paragraph 1(c) of SPLOS/183,
preliminary information submitted by a coastal State in accordance with
SPLOS/183 is without prejudice to the submission in accordance with the
requirements of Article 76 of the Convention and with the Rules of Procedure
and the Scientific and Technical Guidelines of the Commission, and the
consideration of the submission by the Commission.

Outer limits of the continental shelf beyond 200 M

The outer limits of the continental shelf in the East China Sea beyond 200 M from the baselines from which the breadth of the territorial sea of Korea is measured are located in the Okinawa Trough, where the seabed and subsoil of the East China Sea comprises a continuous continental landmass extending from Korea's coast to the limits specified in the Convention.

This preliminary information is confined only to a part of the outer limits of the continental shelf in the East China Sea within the Joint Development Zone (hereafter referred to as "the JDZ"), which refers to the area established under the 1974 Agreement and beyond 200 M from the baselines from which the breadth of the territorial sea of Korea is measured.

The fixed points defining the foot of the continental slope (POS-1 to POS-4, set out in Attachment 1) have been determined in accordance with paragraph 4(b) of Article 76 of the Convention. The fixed points of the outer limits of the continental shelf beyond 200 M referred to in this preliminary information (KOR-1 to KOR-4, set out in Attachment 1) are identical to four fixed points established in the 1974 Agreement. The other two points defining the outer limits of the continental shelf beyond 200 M referred to in this preliminary information (KOR-5 and KOR-6, set out in Attachment 1) are bridging points on 200 M from the baselines from which the breadth of the territorial sea of Korea is measured. Accordingly, the outer limits of the continental shelf beyond 200 M referred to in

this preliminary information are delineated by reference to these six fixed points, which are depicted in Attachment 2.

The list of fixed points and a map of the relevant area are contained in Attachment 1 and 2, which set out the information indicative of the outer limits of the continental shelf in the JDZ and beyond 200 M from the baselines from which the breadth of the territorial sea of Korea is measured..

Status of preparation

The Korea Institute of Geoscience and Mineral Resources has been carrying out the preparation for the submission in accordance with paragraph 8 of Article 76 of the Convention with the cooperation of the Ministry of Foreign Affairs and Trade, the Ministry of Land, Transport and Maritime Affairs, the Ministry of Knowledge Economy and the National Oceanographic Research Institute.

Since 1996, negotiations on the delimitation of boundaries in the East China Sea have been made with the People's Republic of China (hereafter referred to as "China") and Japan, respectively. Korea has also made the necessary consultations with these two countries regarding the submission in accordance with paragraph 8 of Article 76 of the Convention.

Taking into account the consultations with China and Japan with respect to the submission in accordance with paragraph 8 of Article 76 of the Convention, the ongoing negotiations with China and Japan on the delimitation of the boundaries in the East China Sea, and the fact that the submission is being made in accordance with paragraph 8 of Article 76 of the Convention, the Korean Government has decided to submit the information in accordance with paragraph 8 of Article 76 of the Convention.

the East China Sea, and the increasing workload of the Commission, Korea has decided to submit this preliminary information to the Secretary-General.

Intended date of making a submission

Korea intends to make its submission, in accordance with paragraph 8 of Article 76 of the Convention, at an appropriate date, taking into account the progress of ongoing negotiations with China and Japan on the delimitation of boundaries in the East China Sea and other relevant matters.

Korea believes that this submission of preliminary information is intended only to fulfill its obligations under paragraph 8 of Article 76 and Article 4 of Annex II to the Convention, in a manner that avoids prejudice to the unresolved questions relating to the delimitation of boundaries between neighboring States in the East China Sea.

Korea assures the Secretary General, and has assured China and Japan, that this submission is, consistent with paragraph 10 of Article 76 of the Convention, without prejudice to the question of delimitation of the continental shelf in the East China Sea, and is without prejudice to any agreement between Korea and any other State, as well as the rights of any State not party to any such agreement.
