Finally, the Advisory Committee reiterates that further steps need to be taken to align the staffing structure of UNSMIL with that of other missions.

Regarding United Nations Assistance Mission in Afghanistan, the Committee recommends approval of the Secretary-General's proposals. Noting the decrease of 2.5 percent in the proposed budget for 2014, the Committee recalls its previous
