With regards to the **rp**ject schedule the Committee notes theseed to present more detailed information **areac** commends the standardization of the reporting format across construction projectes of the inclusion of all pertinent information.

Committee also notes the net reduction in the overall number of staff resulting from the 2021 office space survey and trusts that the potential implications scobic hanges will be provided to the General Assembly ith regards to isk management, aking into consideration the improved level of confidence of 47 per cent compared with the previous year's confidence level of 27 per cenne, Committee trusts that the Secretary General will continue to closely monitor duritigate project risks, to ensure the delivery of the project within the scope, budget and timeline.

In terms of the new office building of the Unitedations High Commissioner for Refugees (UNHCRe)nd/or the International Organization for Migration, the Committee notes that witil not have any adverse impact on the cost or schedule of the AJ project. Nevertheless, the potential economy of scale or efficiency gains are currently unknown to Committee recommends that additional details on the potential efficiencies and nergy related saving be provided in the next progress report.
