But in this quest, we must also do everything we can to nurture a culture of peace. And if we are to reflect more fully the standard setting norms of international law in domestic law, it is vital for us to have a greater commitment to build a culture of peace, and

Sri Lanka also believes that achieving justice in times of transition from conflict through accountability, redressing victims, and recognizing the rights of victims, promotes civic trust, and strengthens the democratic rule of law. In this regard, States have a duty to guarantee that violations will not re-occur, and a special duty, to reform institutions that have proven to be incapable of preventing such abuses in the past.

Neither can we forget the application of the Rule of Law to sustainable development. The 17 Sustainable Development Goals and 169 targets provide the ample tool kit for the promotion of a culture of peace. This is particularly reflected in Goal 16 or promotion.
