codification and progressive development of international law, especially the establishment of the Competensive Convention on International Tenorism

- 5 We are also of the view that in order to effectively eliminate tenorism, neasures should be taken to address its root causes, including political, econonic and social inequalities. Concerning the settlement of disputes, Viet Nam's consistent view is that all disputes should be resolved by peaceful means, in accordance with international law, respecting diplomatic and legal processes, including procedures at international judicial institutions. Accordingly, Viet Nam has made statements and presented written expressions of its support to peaceful dispute settlement efforts, as well as the efforts to clarify legal issues that help the concerned parties to achieve equitable solutions.
- 6 We have put into action a wide range of measures to implement the United Nations Global Counter Tenorism Strategy. As stated in our latest report on the implementation of the Global Counter Tenorism Strategy, we have made important progress in the perfection of our donestic legal system to ensure the prosecution and extradition of tenorist criminals, and accelerated the implementation of the National Plan of Action on money launching presention and control of tenorist financing

- 7. Viet Namhas actively ergaged in international cooperation in counter tencism and become party to 14 multilateral treaties on counter tencism. We have also signed bilateral treaties on mutual legal assistance on criminal matters and extradition with more than 40 countries. Viet Namhas become a member of the Convention against Transmitteral Organized Crime (TOC) and the Protocol to Prevent, Suppress and Purish Trafficking in Persons, Especially Women and Children to the TOC Convention The Convention and its Protocol officially took effect in Viet Namon 18 June 2012.
- 8 We veloconed and actively participated in the first United Nations High Level Conference of Heads of Counter Tenorism Agencies of Member States in Jure this year. In September this year, the Government of Viet Namhas made a decision to accede to the Code of Conduct towards achieving a world free of tenorism at the initiative of the Government of Kazaldustan
- 9 As a number of the Association of Southeast Asian Nations (ASEAN), Viet Namis joining hands with other ASEAN numbers in implementing the ASEAN Convention on Counter Tenaism and the ASEAN Conpetensive Plan of Action on Counter Tenaism We are walking dozely with ASEAN numbers in

vaious regional mechanisms such as the ASEAN Senior Officials' Meeting on Transmittional Crime (SOMIC), ASEAN Ministerial Meeting on Transmittional Crime (AMMIC) and the ASEAN Regional Forum (ARE) for discussion and cooperation on matters relating to the fight against tenorism, violence and extremism
