- 5. Firstly, Sierra Leone commends the remarkable progress on the legislative agenda of the Commission in the session under review. With disruptions to international trade owing COVID -19 pandemic and attendant ramifications, t he work of UNCITRAL, as the United Nations subsidiary body mandated to assist with the progressive harmonization and modernization of the law of international trade, cannot be more beneficial .
- 6. We therefore welcome the completion and adoption by the Commission of the Legisla tive Guide on Limited Liability the Legislative Recommendations Enterprises; Insolvency of Micro -and Small Enterprises; the Mediation Rules, the Notes on Mediation and the Guide to Enactment and Use of the Model Law on Mediation; and the adoption of the Expedited Arbitration Rules and the new article 1, paragraph 5, of the Arbitration Rules . We also commend the Commission on the approval in principle of the draft commentary to the Legislative Recommendations on Insolvency of Micro -, and Small Enterprise s; and Explanatory Note to the UNCITRAL Expedited Arbitration Rules.
- 7. Secondly, Sierra Leone commends the progress being made by Working Group I Micro-, Small and Medium sized Enterprises (MSMEs), notwithstanding the reported procedural difficulties LQ WKH: RUNLQthJsessloneXXS•V We take note of the October 4 -8 meeting of the Working * URXS Access to credit for MSMEsµas mandate by the Commission to strengthen and complete the work on reducing the legal obstacles faced by MSMEs throughout their life cycles. - 10. We therefore deem its crucial and appropriate for participation of developing States to be enhanced and facilitated. In this regard, we urge that operative paragraph 17 of General Assembly resolution 75/133 be fully oper ationalized by the Secretariat making the process for participation in the meetings of Working Group III widely known, accessible and timeous.
- 11. Thirdly, on other matters relating to the work of the Commission, Sierra Leone welcomes the provisionally approval of the holding of the 55 th session of the Commission in New York. We further take note of the schedule for the working group sessions. Notwithstanding the COVID -19 pandemic, all efforts must be explored and exhausted to ensure the Ne w York in-person meetings are convened in New York. This is vital in not only keeping the good tradition of the Commission, but also to enhance representati veness in its work.
- 12. It is in view of this important representation principle that Sierra Leone len ds it support to the recommendation of the Commission to the General Assembly on the enlargement of the membership of the Commission. We also fully endorse the call of the Chair of the Commission on States to host an inaugural series of UNCITRAL Africa Day in 2022.
- 13. In closing, Madam Chair , the delegation of Sierra Leone is pleased to inform of the preliminary engagement s with the Secretariat of the Commission on cooperation with

Sierra Leone on experience sharing and expertise on the enactment, implementation, and uniform interpretation of UNCITRAL adopted legislative texts. The proposal was /atcoessibh · Vo EDVHG R O6 L H U U D the HFHQW Convention on the Recognition and Enforcement of Foreign Arbitral Award, 1958; the signing of the United International **Nations** Convention on Settlement Agreement Resulting from Mediation 2019, and the United **Nations** Convention the Use of Electronic on Communications in International Contracts 2005 : and the participation of Sierra Leone in UNCITRAL and its Working Groups. We note that this is a significant step in the overall work of the Commission and Secretariat on providing city -building to implement legislative texts adequate capa already adopted, increasing awareness of best practices in the application and interpretation of UNCITRAL texts.
