Mr. Chair,

Armenia supports the continued work of the International Law Commission on its project HQWLWOHG μ , PPXQLW\ RI 6WDWH RIILFLDOV IURP IRUHLJ and practical topic and wæmmendthe approach of the Special Rapporteur in openly setting out her deductive approach from State practice towards progressive develonment of the benefit that results from time spent by the Commission (fifteen years to date) work on an important topic in a deliberate manner. Mr Chair,
