- post], [his] separation [from service], and [the] non-renewal [of his He seeks (a) the decisions to be rescinded, (b) compensation for harm, and (c) referral of the case to the Secretary-General for accountability for possible action to enforce accountability of the relevant leaderships of the Office of Information and Communications Technology (OICT
- 2. The Respondent contends that the application is without merit and requests the Tribunal to reject it in its entirety.
- 3. A hearing was held from 5 to 9 February 2024 via MS Teams in accordance with Order No. 141 (NY/2023) dated 12 December 2023.

- 4. At the hearing, the following witnesses provided testimony: the Applicant (former Senior Programme Manager, UNOPS), Mr. Guenther (Senior Portfolio Manager, UNOPS), Mr. Mariano Junior (Assistant Secretary-General, OICT), Mr. Wandel, (former Executive Director, UNOPS), and (former Director of Operations Support, OICT).
- 5. An official transcript of the hearing recording shall be procured by the Registry and shared with the parties.
