I have the honour to inform you that, following the request from Member States at the last meeting of the General Assembly on COVID-19 related business continuity issues, I will convene informal plenary meetings of the Assembly on this subject on a monthly basis. The next such meeting of the General Assembly will be held on Thursday, 4 March 2021, from 3 p.m. to 5 p.m., in the General Assembly Hall, UN Headquarters.

The meeting will provide an opportunity to discuss business continuity issues with the Secretariat relating to use of UN Headquarters, as well as to hear an update from the Host Country on the status of health conditions related to COVID-19 pandemic and access to vaccines. Given the importance of this discussion, I encourage your personal participation in the informal meeting.

To assist in better planning of the busy months ahead, and following the request from Member States, I have the further honour to circulate a list of the scheduled meetings of the General Assembly and related processes up until 31 March 2021. The schedule of the General Assembly plenary is published daily in the *UN journal* and regularly updated at the General Assembly website: <https://www.un.org/en/ga/info/meetings/75schedule.shtml>.

Herein, I would also like to take the opportunity and reiterate the request from the Secretariat and encourage Permanent Missions to report any COVID-19 cases amongst the members of their delegations to the United Nations reporting portal ([osh@un.org](mailto:osh@un.org)) as soon as possible, to enable immediate action on contact tracing and testing.
