

Migration is a global phenomenon that impacts lives of most people. An estimated 258 million people are international migrants (UN DESA, 2017), and in our increasingly interconnected world, millions are impacted through family ties, economic exchanges and cultural connections. Migration is a powerful driver of sustainable development, for migrants themselves and their communities in countries of origin, transit and destination.


