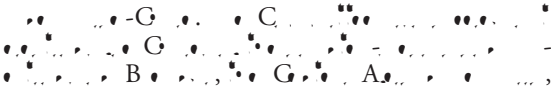

Security Council consideration. 30 June 2015, S/2015/32. The Security Council has adopted a resolution on the protection of civilians in armed conflict. The resolution calls on all parties to armed conflict to do all that is possible to protect civilians from the dangers of military operations. It also calls on the Security Council to continue to monitor the situation and to take appropriate action.
